## To Whom It May Concern;

I am the editor and co-author of the book *Standing In Two Circles: The Collected Works Of Boyd Rice* (ISBN 978-1840681185). In 2005 Boyd Rice and I approached James Williamson / Creation Books, and invited him to publish our then-to-be written book. Mr. Williamson accepted our book proposal, and agreed to publish our book, which I then spent several years compiling and editing for publication. In 2007 my co-author and I signed a book contract with Creation Books / James Williamson, I delivered a finished manuscript for publication, and received an advance of from the company via PayPal.com; following which Creation Books published our book in hardback and softcover editions in the US and UK. Unfortunately, in the four years since our book was first published, my co-author and I have been paid no royalties whatsoever by Creation Books / James Williamson. We hired an attorney in 2010 (the retainer for which exceeded my book advance) and formally demanded payment from Creation Books, but failed to even initiate handling the matter through the US legal system, as we were told that Creation Books does not have a mailing address in the United States, and were instead provided with a Japanese address; from which our legal correspondence was returned as undeliverable.

By our calculations, in the last four years, James Williamson has grossed at least somewhere around from the sales of our book alone (this is gross sales, not taking into account expenses – but as we have not been provided accurate accountings of sales or expenses, we are unable to estimate his net earnings). Boyd Rice and I are alleging that Williamson has breached the contract he signed with us in 2007 and has willfully committed Mail Fraud and Wire Fraud in his dealings with us. A brief rundown of our reasons for making this accusation is as follows:

- Creation Books produced two editions of our book a limited hardback/softcover edition, and a trade paperback edition. Our contract states that we are to be paid a set percentage of 7.5% of sales on these books annually. In four years since the first edition was released, we have been paid no royalties at all.
- Creation Books sold the rights to a French translation of our book and received a \$\)
  advance on sales from the French publisher, Camion Noir. We have not been paid any part of our share of this advance, or any share of royalties on sales of the French language edition.
- Creation Books has attempted to justify its non-payment of royalties to us as being a result of a contract dispute over details pertaining to the limited editions of the book but has skirted our attempts to resolve the issue as a contract dispute by not providing a valid mailing address to us. Creation Books has claimed to not have a US mailing address to which we could send legal correspondence, but we have independently established that the company does indeed have a valid US mailing address a P.O. Box in Washington DC, through which the company receives

payments from its US distributor.

- Creation Books has told us that sales of our book were indefinitely "frozen" until the supposed contract dispute is resolved, but this is manifestly untrue, as the company continues to sell our book through its own website, Amazon.com, the US distributor SCB Distributors, and the UK distributor Turnaround Publisher Services. Although the first printing of our book recently sold out, sales of our book have never actually been frozen.
- James Williamson has created fake email accounts and fake personas through which to deceive us and give us the runaround on the "contract dispute" angle. These include his pretending to be a "Customer Services Representative" named "John Bundrick" and a "designer" named "Candice Black." We have very good reason to believe that both of these email addresses/personas are actually Williamson. Using email meta data we have established that the emails supposedly coming from these different representatives of Creation Books are all coming from the same IP address, and the same computer (named "James-Williamsons-Computer"), located in Bangkok, Thailand.

In short: the terms of our contract have been violated, we have been paid nothing by Creation Books / James Williamson for the three editions of our book, and our attempts to resolve the matter by hiring an attorney have proven fruitless since Williamson is out of reach of the US legal system. Additionally, we have been repeatedly lied to by James Williamson as an attempt on his part to avoid paying us what we are contractually owed. In view of all of this, Boyd Rice and I are alleging that Creation Books / James Williamson is engaging in criminal Mail Fraud and Wire Fraud, and are requesting that the FBI investigate the matter.

I will be happy to provide the FBI with copies of our book contract, my attorney's letter to Creation Books, a cease-and-desist order I sent to Creation Books, printouts of all my emails (with meta data) to and from James Williamson (and his various aliases) and any other information the FBI might require.
